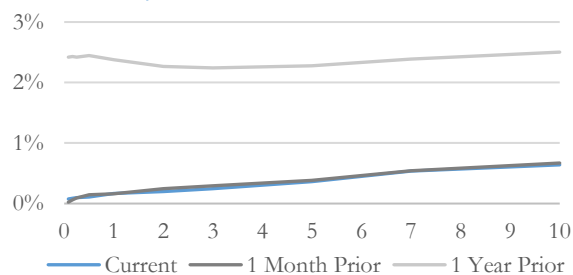

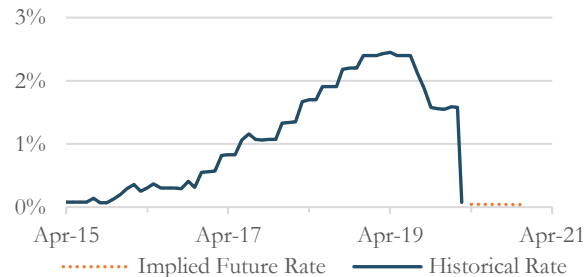

US Treasury Rates



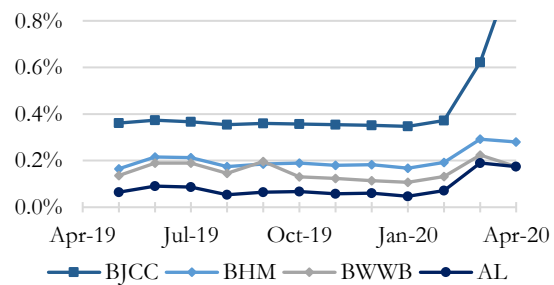
Fed Funds Rate



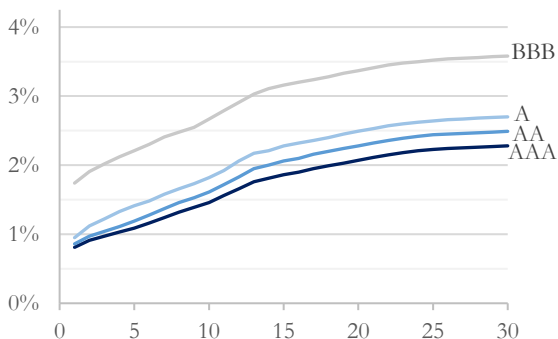
