### PW&Co Market Review

U.S. healthcare transactions remained attractive for both public and private investors throughout 2024, despite below average deal volume compared to recent years. Merger and acquisition transaction volume in the sector failed to rebound to historical levels, ending the third quarter down 35% compared to year-end 2024. Private equity was responsible for approximately 45% of these transactions, the industry's lowest share of transaction volume since the onset of the Covid-19 pandemic, whereas corporate strategic buyers encompassed 55% of reported transactions during the year. Through the first three quarters of 2024, reported middle-market (enterprise value between \$10M and \$250M) healthcare valuation multiples reached a median of 8.7x, a marginal decrease of 0.3x compared to 2023, but the second highest reported value over the last 10 years.

In the venture capital (VC) markets, total deal volume fell 35% compared to 2023; however, healthcare's position in the VC landscape remained stable. Healthcare VC deals accounted for approximately 16.5% of all VC deal activity during the year, remaining unchanged compared to 2023 despite lackluster volume. Early-stage investments in biotechnology (13%), drug discovery (12%), healthcare technology systems (11%), clinic and outpatient services (9%), and therapeutic device (6%) companies accounted for over 50% of total healthcare VC deals through the first three quarters of 2024. Of all healthcare VC deals during the period, 53% were considered "up rounds" (higher implied valuation compared to last financing round), 31% were considered "flat rounds" (lower implied value compared to last financing round).

Heading into 2025, structural tailwinds, including an aging population, increasing demand for specialized healthcare services, and a heightened emphasis on strategic consolidation and technological advancement are expected to bolster deal activity. 



#### S&P 500 Index






## **Private Markets**

## Lending Rates & Inflation








### US CPI (Percent Change from a Year Ago)




#### Healthcare Industry Producer Price Index




### Healthcare & Social Assistance Employment Cost Index




#### Healthcare & Social Assistance Hires and Layoffs (Thousands)

### Healthcare Deal Flow (Last 5 Years)








Healthcare VC Deals as a Share of All VC
